Greetings,

1. The applicant must have a 2.6 GPA.
2. The applicant must be a High School graduate entering a college or University as a full-time student.
3. Continuing two or four year college students will be required to provide verification of financial need. (Financial Aid Award Notice and Student Budget Plan) provided by the school's Financial Aid Administration Office.
4. The packet of information including three letters of recommendations **MUST** be submitted to the sponsoring Chapter by June 15, 2011.
5. The Final Official Transcript **MUST** be received in the office of the Grand Conductress not later than July 1, 2011. The official transcript is marked "**OFFICIAL**", contains the school seal and comes in a sealed envelope.
